Action Items

Informational Items

Accident Report – Man Fell Off the Town Hall Roof

Supervisor Raymond reported a worker from Greenwood Industries fell off of the Town Hall roof. He had his harness on and when he went to hookup he fell. He was helicoptered out and is now in Albany Medical Center. He is going to be ok. Our insurance company was contacted and a representative will be speaking to a representative from Greenwood.

Hardship Request Letter, Haskell, 45 Days to Respond

Supervisor Raymond told the Board the Town of Edinburg has received their first hardship letter. It is from Mr. Haskell. Attorney Walsh read the portion from the local law that covers the hardship portion of the moratorium. She stated a public hearing should be held prior to the March regular Town Board meeting. It will be noticed as any other public hearing. Further discussion ensued as to the owner putting the property up for sale. The board asked if it would be appropriate to have Attorney Walsh contact T. Mitchell who is representing Mr. Haskell and see if he still wants to go ahead with a hardship. Yes, Attorney Walsh will see what his intent is. Supervisor Raymond added the letter of hardship was sent to her not the Town Clerk and it was sent from the firm representing the landowner, not the landowner. The Town Board will still hold a public hearing.

Project Notices from the Adirondack Park Agency

Supervisor Raymond told the Board the Town has received two project notices from the APA the first is for an electric pole in Tennantville. It is actually on the Highway Superintendent's property. This pole will be installed for the placement of a remote reader for National Grid. Highway Superintendent Seelow did not know anything about it, but he had no objections. The second concerns a subdivision by MGH which is primarily in Fulton County. This has to do with a lot that is landlocked and it for a driveway. This is still in the discussion stages, just because the APA approves it does not mean it will be approved by the Town.

B. Brownell Subdivision

B. Brownell was in today asking for his paperwork back that was given to D. Byrne. He is going to file it with the County of Saratoga. His application with the Planning Board was withdrawn. He was given back his money from the Town for the application. Supervisor Raymond told the Board she believes that the Town of Edinburg has nothing to do with the selling of the lot that Mr. Brownell is trying to sell.

Illegal Subdivision

Supervisor Raymond told the Board she received notice that Mr. Frey has caused another illegal subdivision that went to the County again. Supervisor Raymond gave it to Attorney Walsh. Attorney Walsh has been in contact with Mr. Frey's attorney and she cannot believe illegal subdivisions of land are still happening. Mr. Frey may have to be contacted concerning this happening.

Opioid Claims

Supervisor Raymond told the Board she received paperwork on a possible opioid class action suit. Supervisor Raymond told the Board that in the past a policy was made that the Town would not get involved with anything like this.

Saratoga County Sponsorship, Lifeguard and Training Classes for Daycare

Supervisor Raymond told the Board Saratoga County is offering sponsorships for youths in the county from the age of 15 up to become lifeguard. Supervisor Raymond also reported they are offering training classes for people who would like to look into getting a license for people who want to start a daycare center with in their home. This is being offered by Employment and Training.

Wrong Meeting Date

Supervisor Raymond wanted to make the Board aware that the Edinburg Newsletter put in the wrong date for the Town Board meeting. It was put in the Newsletter as the 18th not the 15th.

OLD/NEW BUSINESS

Supervisor Raymond asked if there was any old business or new business to come before the Board.

Building Department and Open Permits

Supervisor Raymond reported that Diane Byrne, Planning and Zoning Board Secretary made a list of all of the open building permits and we are trying to figure out the status of them. The Town Board Members were each given a copy of them. Attorney Walsh stated she did a wonderful job and she is very grateful and appreciative for this. Supervisor Raymond told the Board that B. Decker from CT Male has finalized a house and storage building permits. Further discussion ensued as to the building department and the problems that are coming up. Supervisor Raymond asked the Board to look over the permit list and if they see anything that is done, to let her know and hopefully it can be finalized on the building end. There have been some problems with no inspections in the files, we may have to contact T. Anthony concerning this.

ATTORNEY'S REPORT

Attorney Walsh reported D. Ferguson gave her a copy of the existing Land Use and Zoning Ordinance with possible changes that were put together by the Planning Board members at the time J. Bogert was Chairman. Attorney Walsh has read through them and she will be submitting them to CT Male. Attorney Walsh said she felt much better after going through it and she stated she thinks we are all wondering and hoping we can wrap it up. Supervisor Raymond will be attending the Association of Towns Conference in New York, she is going to be bringing her notes and will be asking questions while there. Attorney Walsh also said the second piece of this is the process, it will be much more clearly laid out. Supervisor Raymond said once the Town receives a contract with CT Male we will look at it and we will need to start setting up meetings. Town Board Member Penino reported that R. Kedik, Planning Board Member has been going through Air B and B's and solar, he will be submitting his concerns with these. It is a fair question to ask CT Male what the Town of Edinburg is lacking in the Town of Edinburg's code and that they may have set up for similar towns of Edinburg's size. Further discussion ensued.

NEW BUSINESS

New Web Site

Town Board Member Greco told the Board that he has been working on updating the website. He has been working with three people, he was sent a PDF form of the old website and Town Board Member Penino and Town Clerk Ferguson went through the proposed changes to the website and Town Clerk Ferguson helped with the changes on the computer so that the information could be sent to Behan and Associates. Lee Hornbeck now has our pages that have been shortened a lot, it went from 21 pages to 7. This has been a nightmare with webhosts and domain name etc. Supervisor Raymond was also helping with making password changes and a pin number has been set up. Behan has gotten the skeleton of the website set up, now it will be the necessities. Supervisor Raymond reported Saratoga County announced another round of Economic Development Grants, the Town will apply for it again.

Woodchips, Parks Grant

Supervisor Raymond told the Board that the woodchips have been delivered to the Town and are at the walking trail ready to be spread.
